

Warranty





Installation:



Prior to installation verify the piping system is not pressurized and that the system has been completely drained.

For proper function of the TrueClean Vent Check valve, the following items should be observed:

- 1. Verification of the product density is greater than the ball density listed in the technical data.
- 2. Vertical installation of the TrueClean Vent Check valve assembly.
- 3. Use a Tri-Clamp clamp and gasket to attach the TrueClean valve to the piping system.

Note: It is advised to use a short outlet tee for installation. Although this valve is designed to be Cleaned-Out-Of-Place (COP), the tee should be short to ensure proper cleaning during Clean-In-Place (CIP).



Process of Operation

Application:



The Vent Check should not be used as a tank vent.

The Vent Check is a sanitary bi-directional air relief valve. It allows air in and out while preventing product from leaking out. The Vent Check may be utilized in various manners, specifically:

High point vent – Installed vertically on the top of a pipeline or container. This application can be used to bleed a pipeline of air pockets that have formed on account of new piping installation or other means of air entrainment in the process.

Check valve - This occurs when product flows into the valve body, moving the polypropylene ball upwards to form a tight seal with the O-ring.

Air Eliminator - To act as an air eliminator, the valve is installed ahead of a pump on top of the inlet pipe. This prohibits the pump from drawing a vacuum because of the spontaneous release of air on the suction side of the pump which prevents cavitation caused by air bubbles that would otherwise be drawn in by the pump.


Vacuum breaker/low CFM breather – The unique lower seat design allows the Vent Check to allow air into the pipeline preventing vacuum conditions. The airflow is equivalent to that of 1" tubing.

Working Principle:

The Vent Check is composed of a vent top clamped to a vent bottom with a freely moving polypropylene ball. The ball seals or opens the Vent Check depending on process conditions.

In **Figure A**, the ball rests against the lower seat, air can flow in and out of the valve due to the specially designed vent bottom.

In **Figure B**, the ball, which is lighter than water, closes against the upper seat when encountering product. This seals air from entering and product from escaping the vent.





Maintenance



Prior to any maintenance, depressurize and drain the piping system.

- 1. Disconnect the TrueClean Vent Check from the piping system. To do this remove the process line clamp by turning the line clamp wingnut counter-clockwise, and remove the gasket connecting the Vent Check to the process tubing.
- 2. Use a 1" cap and clean gasket to close the process.
- 3. Before disassembling, visually check the valve for any corrosion or damage.
- 4. Disassemble the Vent Check by removing the valve body clamp. Turn the body clamp wingnut counter-clockwise until the clamp can be removed. Then remove the clamp and gasket.
- 5. Inspect the valve surfaces for damage. If there is damage to the surface, polishing or replacement may be required depending on the severity of damage. If in doubt, contact your TrueClean distributor for assistance.
- 6. Remove the O-ring from the groove in the vent top.



An O-ring pick tool is necessary to safely remove the O-ring without causing damage to the O-ring or the vent top. Failure to do this may void the warranty.

- 7. Inspect the gasket, O-ring and ball. Replace them if there are any signs of damage.
- 8. Complete a final inspection, looking for corrosion or damage within the device.
- 9. Apply a food-grade FDA approved lubricant to the O-ring and install it in the proper O-ring groove inside the vent top using the O-ring pick tool to assist with install.
- 10. Reassemble the Vent Check.
- 11. Ensure the process is not operating and the area is safe. Remove the cap installed earlier from the process line.
- 12. Install the Vent Check and line clamp back into the piping system.

Cleaning

The TrueClean Vent Check is designed for COP cleaning only. Therefore, follow all steps outlined in the maintenance section above, paying special attention to the warning and caution. While the valve is disassembled, standard operation procedures at the respective facilities should be followed to clean the valve.
